- ECED Cluster Quality Working Group promotes access to quality ECED services to all children including children with disabilities.
- CESA ECED Cluster -Objective 1: Intensify action to improve equitable access to quality ECED programmes and services. This objective contributes to achievement of:
- > CESA 16-25 Sub Objective 2: Education infrastructure, and policies that ensures a conducive learning environment **for all**, to expand access to quality education.
- > CESA 16-25 Sub Objective 5: Accelerate processes leading to gender parity and equity.
- Children with disabilities are amongst the most excluded due to barriers existing in supply & demand of services.
- Promoting IECED requires a comprehensive approach in the design and implementation of programmes and services.
- The Disability Committee was set up by the Quality Improvement Working Group of the ECED Cluster, to promote the inclusion of children with disabilities in quality ECED services.

Objectives/Functions of the Disability Committee

The Objective of the Disability Committee is to advocate and advance issues of IECED in the region. The Disability Committee will;

- ➤ Generate knowledge on trends, achievements, and challenges regarding disability inclusion in ECED in the region.
- Convene and participate in knowledge exchange events and coordinate sensitizations on disability inclusion in ECED.
- Advocate for the development, implementation, and evaluation of Inclusive ECED policies at national and regional levels.
- Collaborate with AU CESA ECED Cluster working groups and key stakeholders to improve efficiency, effectiveness, and relevance of inclusive ECD service delivery.
- ➤ Mobilize and enhance partnerships to improve access to quality ECED for children with disabilities.
